Town Board Meeting
July 8th 2025

Present: Town Supervisor JoAnn Nazarian, Town Board Members Zachary Gelling, Thomas Millert, Matthew Notaro, Justin Hart and Town Clerk Darlene Owens.

At 6:00 p.m. Nazarian called the meeting to order with the Pledge Allegiance.

SEQR Motion:

Gelling made a **Motion** that all actions taken tonight are excluded, exempt or Type II actions for the purpose of the State Environmental Quality Review Law unless otherwise stated, seconded by Millert. All ayes; Gelling, Millert, Notaro, Hart and Nazarian.

Sandy Keith

Keith wanted to know who took care of Schroepel bridge and she said she knew the town plowed it but there are a lot of potholes and is it the town who takes care of that. Nazarian said we get paid by the County to plow that road. Nazarian said you should call NYS DOT.

Keith also wanted to know about Soar Farms and Wetlands. Nazarian said the Solar Farms they get a pilot agreement in lieu of taxes which Oswego County IDA negotiates the county host which funds are paid to the Town in lieu of taxes. Nazarian said the wetlands receive agriculture exemption and contribute minimum to the taxes.

Jim Murphy

Murphy said he was concerned with the truck traffic on the road, he thinks there should be more signage on County Route 57 for Huntley Road. Murphy said that trees and brushes are covering the weight limit signs on Huntley and they get a lot of trucks coming through that weigh more than the limit. He said Berrett Paving the trucks are to exit out of there and turn right but they don't always. He said they don't even know the speed limit on the road because there is no signage. Nazarian said you can get a petition for a lower speed limit and give it to the Town. The Town will send it to the County and the County sends it to State to do a study.

County Route 57 and Huntley Road Water Project

Nazarian said she had Resolution authorizing submission of funding application for County Route 57 & Huntley Road Water Project so the Town could seek funding through Clean Water State Revolving fund, NYSEFC water Infrastructure Improvement Act, Department of Environmental Conservation, Water Quality Improvement Program and others. Nazarian said that she would submit on behalf of the Town. Nazarian made the **Motion** to approve the Resolution seconded by Gelling. All ayes; Gelling, Millert, Notaro, Hart and Nazarian. Schroepel South Water Project

Nazarian said she had Resolution authorizing submission of funding application for Schroepel South Water District project so the Town could seek funding through Clean Water State Revolving fund, NYSEFC Water Infrastructure Improvement Act, Department of Environmental Conservation, Water Quality Improvement Program and others.
