

April 8, 2024 Board Meeting Update

Bankrupt Road Water District:

- We have received the final sampling results and have sent them Into the Department of Health for review. Once
 approval Is granted, we will send out hook-up Information packets to the Individual property owners that have a
 new service. Restoration still has to be completed across the project area. The contractor Is waiting for all
 areas to dry up before putting heavy equipment back out there and making more of a mess.
- USDA RD will be holding a closing on the long term bonds with the Town, scheduled for April 24th. The Town has
 remaining grant funds In place as we work through restoration and punch list Items with the contractor.

CR 57/Huntley Road:

- We have applied for additional Congressional Discretionary funding for this project. We will apply for additional WIIIA (Water Infrastructure Improvement & Intermunicipal Grants) once a new round Is announced.
- We are continuing work on the construction documents (plans and specifications) as we head towards agency review.
- Once we feel the construction documents are complete, we will send the documents out for Agency Review and complete the permitting process. The Agencies will Include DEC, CSX, County Highway, DOH, Army Corps of Engineers, OCWA, the Canal Corporation and the Town.
- As we wait for additional survey, the agencies will comment, and we will respond to the comments to gain approval for bidding in the early Summer

South Water District:

- Agriculture and Markets had some comments on the Preliminary and Final Notice of Intent that we are working through. We are working on the Environmental Report and will follow up on any agency responses yet to be received for the project. We will be working through the various funding application in the coming months.
